

<u>Surface Preparation</u>: To properly achieve adhesion of sealants, all oils, grease, tars, coatings, asphalt and/or other contaminants must be removed. Sandblasting is the preferred method of cleaning the concrete. After cleaning, blow off all residue with compressed air.

At Marked locations, cut holes in fabric reinforced moisture barrier slightly smaller then the inside circle layer with the peel away adhesive on the drain tube assembly.




Clean area of Moisture barrier around the cut holes with Rubbing Alcohol. Peel paper off adhesive side of Drain Tube Assembly and adhere to Moisture Barrier, making sure that it is centered over the cut holes. Utilizing a seam roller, roll over the entire adhesive area to ensure a strong bond line between the two pieces.

Mark and pre-drill anchor locations on the Aluminum Retainer spaced at 16" O.C starting 4" in from either end. Utilizing the pre-drilled Aluminum retainer, hold the Fabric reinforced Moisture Barrier and (Optional) Drain Tube Assembly under slab and press Aluminum Retainer against the concrete as shown. The Aluminum retainer will act as a template for locations where the contractor will need to drill for anchor installation.

Note: After anchor holes have been drilled, clean out holes of debris during the drilling process.



Contractor Note: Before installing the concrete screw anchors, apply a bead of sealant (By Others) on the underside of the concrete where the moisture barrier will be installed. This is to ensure that no water will propagate between the systems.

Utilizing the supplied concrete screw anchors, fasten the retainer and gutter system to the concrete slab. Fill void and the end of the retainer with sealant (By Others), as shown. Connect optional Drain Tube assembly to the projects drain system (By Others).



Cut splice strip to length that equals the width of the Fabric Reinforced GutterFlex.

Peel backing paper from Splice Strip

Clean contact area of GutterFlex to receive the Splice Strip with Mineral Spirits. Bring the two ends of the GutterFlex Moisture Barrier to within 1/64" of each other. Center splice strip over gap and apply to GutterFlex Moisture Barrier.

Note: After Splice strip has been applied, WBA Recommends using the Seam Roller to ensure that no air bubbles will be present and that the splice strip is well adhered to the GutterFlex. Pay special attention to all edges.





3. Clean and Prepare Work Surface

Work Surface:

- Prior to beginning work, installer shall prepare a clean, sound work surface that will provide a stable, clean surface for the field assembly of the Wabo®GutterFlex Splice.
- Confirm joint substrate is dry, clean and ready for the Wabo®GutterFlex.
- Best practice would be a clean, dry sheet of plywood resting safely on two saw horses.



4. Splice Procedure

- 1. Place equal size pieces of Wabo®GutterFlex end-to-end on your clean, dry work surface so that a straight, even butt splice is formed.
- 2. Use the provided Wabo®GutterFlex Splice Primer and prep at least 3.0" of material on each side of the butt splice (see below). Fully coat (etch) the 3.0" area on each side with Primer, then allow 2-3 minutes for it to 'flash off'. Care should be used to ensure that this area remains clean.
- 3. Gently press the Wabo®GutterFlex Splice Tab onto the primed / etched area. Use the roller to roll out all air pockets for stronger bond between Splice Tab and Wabo®GutterFlex. Start at one side and work your way across the entire Splice Tab.
- 4. For best splice performance, apply light heat to splice tab during rolling operation (see Image #1 next page). Allow to cool before flipping Wabo®GutterFlex to opposite side.
- 5. Gently flip the Wabo®GutterFlex System over and repeat Steps #1 to #4 on the underside to ensure both side of the butt splice are covered with a Wabo®GutterFlex Splice Tab.

INSTALLATION TIP: In cold temperatures, store material in a heated area 24hrs prior to installation. In hot temperatures, store material out of direct sunlight and not in an enclosed storage container where temperatures may exceed 100°F (38°C).


1. Drain Tube Assembly (optional)

1. For proper construction of your Drain Tube Assembly we recommend using the same plywood / sawhorse work bench used for the Splice; however it is now recommended to drill a hole in the center of the plywood (minimum diameter = 3.5") to allow the Drain Tube to hang freely through the opening.



2. Wabo®GutterFlex Sheet Good prep...

- 1. Rollout Wabo®GutterFlex sheetgood on top of plywood worksurface.
- 2. Invert Drain Tube Assembly, place on top of Wabo®GutterFlex and trace outside diameter as shown below.





- 2. Fully coat (etch) the area shown below on the Drain Tube Assembly Flange using the Primer provided.
- 3. Allow 2-3 minutes for it to 'flash-off' properly.

10. Drain Tube Assembly Assembly...

- 1. Apply Drain Tube Assembly to WaboGutterFlex sheet good by allowing drain tube to hang through the hole in the WaboGutterFlex and the plywood worksurface.
- 2. Gently press the 2 items together (shown below).
- 3. Use roller across entire surface to press any trapped air out. (Required for proper watertight seal).
